  require a second telephone line and new phone system. Spectrum quoted \$1,050 for complete set up and
  installation and training. The monthly cost will be approximately \$254.99. D. Bass-motion to purchase and sign
  contract with Spectrum for new phone system at a cost not to exceed \$1,500, using ARPA funds, K. Fickiesseconded, roll call vote, motion carried 5-0-0
